RESOLUTION NO. 4975

A resolution providing for canvassing the returns and declaring the result of the special election held in Parish of St. Charles, State of Louisiana, on Saturday, October 20, 2001, to authorize the renewal of a special tax therein.

BE IT RESOLVED by the St. Charles Parish Council (the "Governing Authority"), acting as the governing authority of Parish of St. Charles, State of Louisiana (the "Parish"), that:

SECTION 1. Canvass This Governing Authority does now proceed in open and public session to examine the official tabulations of votes cast at the special election held in Parish of St. Charles, State of Louisiana, (the "Parish"), on SATURDAY, OCTOBER 20, 2001, to authorize the renewal of a special tax therein, and said Governing Authority does further proceed to examine and canvass the returns and declare the result of the special election.

SECTION 2. Procès Verbal. A *Procès Verbal* of the canvass of the returns of said election shall be made and a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office; another certified copy thereof shall be forwarded to the Clerk of Court and *Ex-Officio* Recorder of Mortgages in and for the Parish of St. Charles, who shall record the same in the Mortgage Records of said Parish; and another copy thereof shall be retained in the archives of this Governing Authority.

SECTION 3. Promulgation of Election Result. The result of said election shall be promulgated by publication in the manner provided by law.

SUMMARY 10 YEAR 1.13 MILLS PROPERTY TAX RENEWAL FOR ABATEMENT, CONTROL, ERADICATION AND STUDY OF MOSQUITOS AND OTHER ARTHROPODS OF PUBLIC HEALTH IMPORTANCE AND ALL ACTIVITIES INCIDENTAL THERETO

Shall the Parish of St Charles, State of Louisiana (the "Parish"), levy a one and thirteen hundredths (1.13) mills tax on all property subject to taxation in said Parish for a period of ten (10) years, beginning with the year 2002 and ending with the year 2011, for the purpose of the abatement, control, eradication and study of mosquitos and other arthropods of public health importance and all activities incidental thereto?


