An ordinance to approve and authorize the execution of Amendment No. 1 to Ordinance No. 00-11-18 between Cycle Construction Co., L.L.C. and St. Charles Parish for the construction of the Bar None West Ditch Improvements (Phase II) Project P000319.

WHEREAS, Ordinance No. 00-11-18 adopted November 20, 2000, by the St. Charles Parish Council approved and authorized the execution of a contract with Cycle Construction Co., L.L.C. for the construction of the Bar None West Ditch Improvements (Phase II); and,

WHEREAS, a certain paragraph in the basic agreement was inadvertently left out of the contract that would reduce the cost to the Parish of the Clerk of Court filing fees.

TO

**AMENDMENT TO THE CONTRACT FOR BAR NONE WEST DITCH
IMPROVEMENTS – PHASE II**

Section 00500, Article 8.1 is hereby amended to include the following paragraph:

Section 00700, General Conditions, pages 00700-1 through 00700-31 and Section 00800, Supplementary Conditions, pages 00800-1 through 00800-25, and Secondary Supplementary Conditions have been adopted by the St. Charles Parish Council as a Standard General Conditions and Supplementary Conditions for Construction Contracts. Those General Conditions and Supplementary Conditions are to be referred to in the agreement and contract as "GEN.COND, CONST – 7/98 filed in MOB 682, Folio 230 filed with the St. Charles Parish Clerk of Court."

All other provisions of said contract shall remain as first written.
