Thank you again for your service on the CZAC. Clay is on vacation this week, so I'm reaching out to help keep us on task to re-establish the CZAC. Will you please reply to this email to let me know if you have any interest in continuing on the committee? If so, I'll have the Council Secretary send you a questionnaire. Then, after this week, Clay and I will schedule a telephone call or in-person meeting to discuss what we have planned for the CZAC in the coming years and the other people who have expressed an interest in serving.

I am sorry that the CZAC stopped meeting so unceremoniously. Earl Matherne has expressed a deep interest in helping us make sure members who served on the CZAC and established our approved Local Coastal Program receive their overdue recognition. We are working on recognitions as we work to reestablish the CZAC.

On July 10, the Planning Commission, serving as interim CZAC, will consider minor revisions to The Local Coastal Program ordinance. The ordinance contains conflicting sentences regarding a 9-member CZAC and a 7-member CZAC as well as this language: (b) A member shall be removed by the parish council only for good cause during their four-year term. Within the first six months of each term, the council may remove or replace committee members without cause. With no action on the part of the council, committee members shall remain in their seats as there are no express term limits. The committee chairperson is to be selected by standing members.

Parish Legal Services interprets that language to mean CZAC members are appointed for life, which puts Clay and me in the awkward position of having to ask people who gave so much and served so long to officially resign.

Thank you again for your time on the committee. I look forward to meeting you.
