An ordinance to amend the St. Charles Parish Zoning Ordinance of 1981, to change the zoning classification from R-1A(M) to M-1 on property designated as Lot G, Block 11, Almedia Plantation, 180 Almedia Road, St. Rose as requested by Karen Abate.

WHEREAS, Karen Abate requests a rezoning from R-1A(M) to M-1 on property designated as Lot G, Block 11, Almedia Plantation, as shown on the survey by E.M. Collier, PLS, dated July 15, 1961; and,

WHEREAS, the Planning and Zoning Department recommended denial of the request; and,

WHEREAS, the Planning and Zoning Commission recommended denial of the request at its regular meeting on November 6, 2025.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. The Zoning Ordinance of 1981 is amended to change the zoning classification from R-1A(M) to M-1 on property designated as Lot G, Block 11, Almedia Plantation, as shown on the survey by E.M. Collier, PLS, dated July 15, 1961, as requested by Karen Abate.

SECTION II. The Department of Planning and Zoning is authorized to amend the Official Zoning Map, St. Charles Parish, Louisiana to reflect this reclassification from R-1A(M) to M-1 on property designated as Lot G, Block 11, Almedia Plantation, as shown on the survey by E.M. Collier, PLS, dated July 15, 1961, as requested by Karen Abate.
