RE:

CHURCH STREET CONFIRMATION

During the course of my term in Office, issues regarding Church Street in Paradis have come up from time to time. A question as to whether or not Church Street is public, private, or part public or part private has been raised. As an Elected Official, it is my duty and obligation to learn what part or parts of the street fall under the authority of the Parish. This information is needed in order for me to know what portion (if not all) of Church Street that I can address issues on.

The question as to whether or not any part of Church Street is private was asked to Chief Administrative Officer, Mr. Timothy J. Vial on August 27, 2010, as a result of a citizen requesting an issue be addressed on Church Street. (See attached documents.) The work was not done by the Public Works Department due to their concern as to whether Church Street was public or private. Since that time I have come to learn that the work has been done by the Parish without me ever receiving an answer as to whether Church Street is public or private. Please have the ownership of Church Street determined and provided to me on a map, showing the limits of Church Street.

Your assistance in providing me this information is greatly appreciated.
