


**PLEASE TAKE NOTICE** that by virtue of a written contract dated October 7, 2015, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, V. J. St. Pierre, Jr., duly authorized by Ordinance No. 15-10-1 adopted by the St. Charles Parish Council on October 5, 2015 and Volute, Inc., 313 Venture Boulevard, Houma, LA 70360 through Dale C. Thompson, Jr., President, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct, and complete in a thorough and workmanlike manner construction of Dunleith Canal Stabilization Phase 5 in St. Charles Parish, Louisiana for the price and sum of ONE MILLION THIRTY-EIGHT THOUSAND, TWO HUNDRED AND SIX DOLLARS AND NO/100THS (\$1,038,206.00), the work under the Contract to be completed within One Hundred Eighty (180) calendar days from the date of the Notice to Proceed. Said basic work to include furnishing and installing sheet piling and cap, clearing and grubbing, backfilling, sodding, and hydroseeding as shown on the Drawings, Specifications and Contract Documents for Parish Project No. P081102-6, Dunleith Canal Stabilization Phase 5, as prepared by Evans-Graves Engineers, Inc., stamped June 25, 2015. The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents and Specifications may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

The property upon which the above described improvements are to be constructed is generally described as the Dunleith Canal in Ormond Subdivision of Destrehan, on the East Bank of St. Charles Parish as per the detailed plans and specifications prepared by Evans-Graves Engineers, Inc. All of the work of this Contract is located in rights-of-way owned and/or granted right to use by St. Charles Parish.
