An ordinance to approve Amendment No. 3 to the Contract for Engineering Services with Shread-Kuyrkendall & Associates, Inc. for Project Representation for Subdivision Construction, Project No. P000301 (2004).

PROJECT DESCRIPTION

WHEREAS, said contract was extended by Ordinance No. 01-9-4 on September 4, 2001, and Ordinance No. 02-11-7 on November 4, 2002; and,

WHEREAS, it is the desire of the St. Charles Parish Council to extend the term of this contract for an additional year in accordance with Paragraph 5.1 of said contract.
