An ordinance approving and authorizing the execution of a Contract with Cycle Construction Company, L.L.C., for Engineer's Canal Phase 1 Bank Stabilization (Project No. P190301) in the amount of \$1,405,350.00.

WHEREAS, Ordinance No. 19-3-9 adopted on March 25, 2019, by the St. Charles Parish Council, approved and authorized the execution of a Professional Services Agreement with Shread-Kuyrkendall & Associates, Inc., for providing all necessary professional engineering services for an approximately 4,100-foot sheet pile wall along the southeastern-side of Engineer's Canal for Engineer's Canal Bank Stabilization (Project No. P190301), in the not to exceed amount of \$300,554.00; and,

WHEREAS, sealed bids were received by St. Charles Parish on October 3, 2023, for Engineer's Canal Phase 1 Bank Stabilization (Project No. P190301); and,

WHEREAS, Shread-Kuyrkendall & Associates, Inc. has reviewed the bids and recommends that the Contract be awarded to the low bidder, Cycle Construction Company, L.L.C., in the amount of \$1,405,350.00.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the bid of Cycle Construction Company, L.L.C., for the construction of Engineer's Canal Phase 1 Bank Stabilization (Project No. P190301) is hereby approved and accepted in the amount of \$1,405,350.00.

SECTION II. That the Parish President is hereby authorized to execute said Contract on behalf of St. Charles Parish.

PLEASE TAKE NOTICE that by virtue of a written contract dated December 1, 2023 St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, Matthew Jewell, duly authorized by Ordinance No. 23-11-13 adopted by the St. Charles Parish Council on November 20, 2023, and Cycle Construction Company, L.L.C., 6 E. 3rd Street, Kenner, LA 70062, through Jonathan N. Kernion, Jr., Vice President, entered into a contract to furnish all labor and materials and perform the work required to build, construct, and complete in a thorough and workmanlike manner in connection with the following: Engineer's Canal Phase I Bank Stabilization, Project Number P190301, in St. Charles Parish, Louisiana, for the price and sum of ONE MILLION FOUR HUNDRED FIVE THOUSAND THREE HUNDRED FIFTY DOLLARS AND 00/100, (\$1,405,350.00), the work under the Contract to be completed within one hundred eighty (180) calendar days from the date of the Notice to Proceed.

Said basic work is generally described as follows: Install a new sheet pile bulkhead along Engineer's Canal, approximately 500 LF according to the Contract Documents prepared by Shread-Kuyrkendall & Associates, Inc. dated March 1, 2023 and certified August 22, 2023.

The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Applications for Payment in accordance with Article 15 of the General Conditions. The complete Contract Documents may be reviewed at the Records Office of the St. Charles Parish Council, 3rd floor, Parish Courthouse, 15045 River Road, Hahnville, LA.

Principal Work Location: Norco, LA. All of the work of this Contract is located in rights-of-way owned and/or granted right to use by St. Charles Parish.
