ORDINANCE NO. 20-8-10

An ordinance to approve and authorize the execution of a construction contract with Fleming Construction Company, LLC for Project No. P190502, Schexnaydre Pump Station Improvements, in the amount of \$654,016.00.

WHEREAS, the Schexnaydre Pump Station Improvements project will increase stormwater pumping capacity in this section of the Parish; and,

WHEREAS, sealed bids were received by St. Charles Parish on July 14, 2020, for the Schexnaydre Pump Station Improvements project; and,

WHEREAS, Evans-Graves Engineers, Inc., Stephen Lundgren, P.E., the Consulting Engineer for the Project, has reviewed the bids and recommended that the contract be awarded to the lowest responsive bidder, Fleming Construction Company, LLC, in the amount of \$654,016.00.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the bid of Fleming Construction Company, LLC for the construction of Project No. P190502, Schexnaydre Pump Station Improvements, is hereby approved and accepted, in the amount of \$654,016.00.

SECTION II. That the Parish President is hereby authorized to execute said contract on behalf of the Parish of St. Charles.

SECTION III. A final Notice of Contract shall be printed and filed in place of the contract documents with the St. Charles Parish Clerk of Court and in the records of the St. Charles Parish Council.

PLEASE TAKE NOTICE that by virtue of a written contract dated August 18, 2020, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, Matthew Jewell, duly authorized by Ordinance No. 20-8-10, adopted by the St. Charles Parish Council on August 10, 2020, and Fleming Construction Company, L.L.C., 23 East Airline Drive, Kenner, LA 70062, through Jana Fleming Katz, Member, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct, and complete in a thorough and workmanlike manner: Project No. P190502, Schexnaydre Pump Station Improvements, in St. Charles Parish, Louisiana for the price and sum of SIX HUNDRED FIFTY-FOUR THOUSAND, SIXTEEN DOLLARS AND 00/100 (\$654,016.00). The work under the Contract to be completed within one hundred eighty (180) calendar days from the date of the Notice to Proceed.

Said basic work consists of furnishing and installing a new 48" storm water pump complete with diesel engine and all connections, piping, and controls, new 48" discharge pipe, temporary bypass pumping during construction, structural modifications, and removal and disposal of existing 30" pump and diesel/electric motor, 30" discharge pipe, and associated mechanical/electrical components, connections, and controls, according to the Contract Documents prepared by Evans-Graves Engineers, Inc. dated April 30, 2020 and certified July 23, 2020.

The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

Principal Work Location is the Schexnaydre Drainage Pump Station in New Sarpy, on the east bank of St. Charles Parish, Louisiana. All of the work of this Contract is located in rights-of-way owned and/or granted right to use by St. Charles Parish.
