

NOTICE OF CONTRACT

OAK STREET PUMP STATION IMPROVEMENTS

PLEASE TAKE NOTICE that by virtue of a written contract dated January 9, 2019, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, Larry Cochran, duly authorized by Ordinance No. 19-1-4, adopted by the St. Charles Parish Council on January 7, 2019, and Sealevel Construction, Inc., P.O. Box 1037, Thibodaux, LA 70302, through Richard J. Roth, President, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct, and complete in a thorough and workmanlike manner: Parish Project No. P080502-18A, Oak Street Pump Station Improvements, in St. Charles Parish, Louisiana for the price and sum of ONE MILLION SIXTY-TWO THOUSAND EIGHT HUNDRED SEVENTY DOLLARS AND 00/100 (\$1,062,870.00). The work under the Contract to be completed within Two hundred forty (240) calendar days from the date of the Notice to Proceed.

Said basic work is generally described as follows: furnish and install a new 36" pump and 36" discharge/carrier pipe within an existing 48" concrete casing pipe through a railroad embankment (to remain in place), complete with motor, VFD drive, and all connections and controls; furnish and install a new 350kW generator and electrical work associated with the new pump; placement of riprap; and removal and disposal of existing 24" pump, 24" discharge pipe and electrical components according to the Contract Documents prepared by Evans-Graves Engineers, Inc., dated and certified December 14, 2018. The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions.

The complete Contract Documents may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

The property upon which the above described improvements are to be constructed is located along a drainage canal located near the CN Railroad at 812 Oak Street, St. Rose, on the east bank of St. Charles Parish, Louisiana. All of the work of this Contract is located in rights-of-way owned and/or granted right to use by St. Charles Parish.
