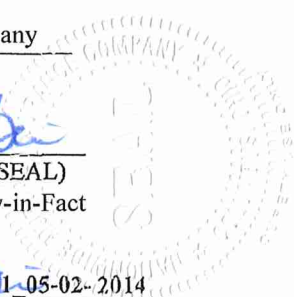

Power of Attorney
