DESCRIPTION:

Proposed fill of a ±1.5 acre area for construction of a lot for equipment storage. Approx. 1,237 cu. yds. of river sand will be used as fill. Approx. 1.35 acres of

forested wetlands will be impacted as a result of this activity*.

Box 82215, Baton Rouge, Louisiana 70884. All comment letters should contain both the applicant's name and the appropriate application number.

State of Louisiana Coastal Use Permit Criteria


The decision on whether or not to issue a Coastal Use Permit will be based on an evaluation of the probable impacts of the proposed activity in accordance with the state policies outlined in R.S. 49:214:22. The decision will reflect the national concern for both protection and utilization of important resources. The decision must be consistent with the state program and approved local programs for affected parishes and must represent an appropriate balancing of social, environmental and economic factors. All factors which may be relevant to the proposal will be considered; among these are flood and storm hazards, water quality, water supply feasible alternative sites, drainage patterns, historical sites, economics, public and private benefits, coastal water dependency, impacts on natural features, compatibility with the natural and cultural setting and the extent of long term benefits or adverse impacts.

Public Hearings

Any person may request, in writing, within the comment period specified in this notice, that a public hearing be held to consider this application. Request for public hearings shall state, with particularity, the reasons for holding a public hearing.




Original Proposed Fill




Proposed Fill Completion
