**ORDINANCE NO.** \_09-2-10

An ordinance to approve and authorize the execution of an Act of Donation by St. Charles Parish to the St. Charles Parish Law Enforcement District for a certain 7.7390 Acre parcel of property, identified as Lot 4B-2, Ashton Plantation located along Sugarland Parkway in Luling.

WHEREAS, on January 22, 2001 the St. Charles Parish Council adopted Ordinance No. 01-1-18 accepting an Act of Onerous Donation by Esperanza Land Company of Tract 4-B located along Sugarland Parkway in Ashton Plantation; and

WHEREAS, said Tract of land contained 33.98 acres and Sheriff Greg Champagne has requested that the Parish Donate a certain 7.7390 acre portion of said tract to the St. Charles Parish Law Enforcement District for the Sheriff's Office to construct an office building; and,

WHEREAS, it is the desire of the Parish Council to approve said request.

## THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

**SECTION I.** That the Act of Donation by St. Charles Parish to St. Charles Parish Law Enforcement District for Lot 4B-2, located along Sugarland Parkway, Ashton Plantation in Luling is hereby approved.

**SECTION II.** That the Parish President is hereby authorized to execute said Act of Donation on behalf of St. Charles Parish.

Who declared that it does by these presents grant, bargain, convey, transfer, assign, set over, abandon and deliver, with all legal warranties and with full substitution and subrogation in and to all the rights and actions of warranty which it has or may have against all preceding owners and vendors, and does by these presents make a manual gift and donation unto:

**ST. CHARLES PARISH LAW ENFORCEMENT DISTRICT**, a political subdivision of the State of Louisiana, herein represented by its Sheriff, Gregory C. Champagne, and whose mailing address is P. O. Box 426, Hahnville, Louisiana;

hereby appearing for the purpose of accepting the following described property, to-wit:

A CERTAIN LOT OR PORTION OF GROUND, together with the improvements thereon, rights, ways, privileges, servitudes and advantages thereunto belonging or in anywise appertaining, situated in the Parish of St. Charles, State of Louisiana, on the right bank of the Mississippi River, which is parcel of ground is designated as 4B-2 according to a survey entitled "SURVEY PLAT AND RESUBDIVISION OF TRACT 4B OF ASHTON PLANTATION INTO LOTS HEREIN DESIGNATED AS LOTS 4B-1 & 4B-2 OF ASHTON PLANTATION, LULING, ST. CHARLES PARISH, LOUISIANA" by Stephen P. Flynn, P.L.S. dated December 22, 2008, and further described as follows:

Said parcel of ground is described therein as Lot 4B-2 and begins at an iron rod located on the northern boundary line of Sugarland Parkway 187.56' from the intersection of the southern boundary of Rue La Cannes at its intersection with the northern boundary of

Sugarland Parkway, the point of beginning; thence proceeding S38°26′09″W for a distance of 445′ to an iron rod located in the northern boundary of Sugarland Parkway; thence proceeding N51°23′51″W for a distance of 883.08′ to an iron rod located on the northern boundary of Tract 4B of Ashton Plantation; thence proceeding N39°11′48″W for a distance of 320.67′ to an iron rod located on the northern boundary of Ashton Plantation; and thence S59°37′07″E for a distance of 887.57′ to the point of beginning.

The parcel of ground transferred herein contains 7.7390 acres.
