ORDINANCE NO. 01-12-12

An ordinance to amend the Code of Ordinances of St. Charles Parish, to revise Chapter 15, Section 15-9, to provide an exception to the Twenty-five (25) Miles Per Hour Speed Limit, to lower the speed limit on the **800 Block of Marino Drive, Norco; 800 Block of Clayton Drive, Norco; and the First three Blocks of West B Street in Norco from River Road to the CNIC Railroad to Fifteen (15) Miles Per Hour.**

WHEREAS, Paragraph (a) of Section 15-9 of the Code provides that it is unlawful to operate any motor vehicle at a speed in excess of twenty-five (25) miles per hour on Parish streets; and,

WHEREAS, Paragraph (a) of Section 15-9 has been amended to provide exceptions; and,

WHEREAS, The Parish Council desires to provide an exception to lower the speed limit allowed on the 800 Block of Marino Drive, Norco; 800 Block of Clayton Drive, Norco; and the first three Blocks of West B Street in Norco from River Road to the CNIC Railroad.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION 1. That the St. Charles Parish Code, Section 15-9 of the Traffic Code is hereby amended by adding Nos. 33, 34, and 35 as follows:

"(a) It shall be unlawful for any person to operate any motor vehicle at a speed in excess of twenty-five (25) miles per hour on any of the Parish streets, roads, highways and bridges,

EXCEPT:

(33) 800 Block of Marino Drive, Norco

(34) 800 Block of Clayton Drive, Norco

(35) First three Blocks of West B Street, Norco (From River Road to CNIC Railroad)

The foregoing ordinance have been submitted to a vote, the vote thereon was as follows:
