WHEREAS, Collin has spent the last 11 years as an active member of the Scouts spending the last 5 years preparing to become an EAGLE SCOUT; and,

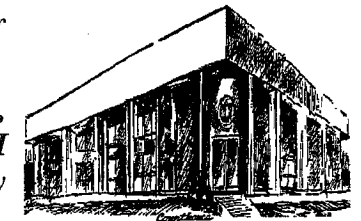
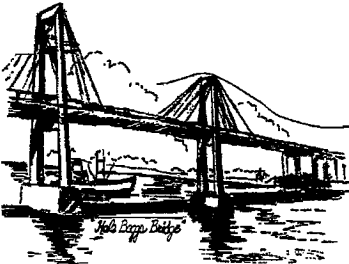
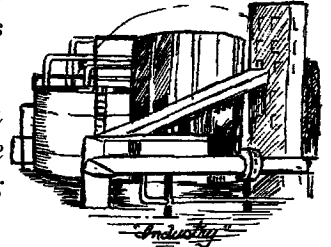
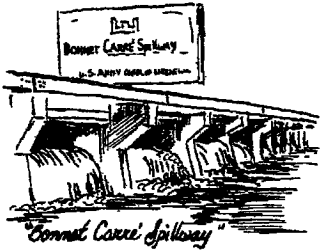
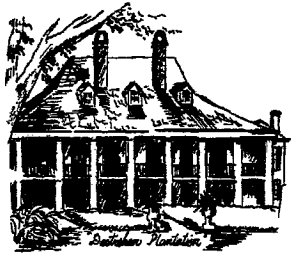
