We, the undersigned, who are residents of Country Cottage Estates (hereby referred to as CCE) in Montz, Louisiana, hereby oppose the plans by O T Properties, LLC, to have the proposed subdivision, Bocage Estates, use Lindsey Court in CCE as an access to the subdivision. We also oppose any approval, even preliminary, until a Drain Impact Analysis is submitted and approved.

The residents of CCE, who are members of the Country Cottage Estates Homeowners Association, Inc., believe O T Properties, LLC, by requesting CCE as an access to Bocage Estates is in violation of Louisiana Civil Code, Article 692, which states that the location of a passage shall be taken along the shortest route from the enclosed estate to the public road. Further pursuant to the Louisiana Civil Code the location of a right of passage must be at a place least injurious to the intervening lands.

Here, Mr. Robert Oubre, Manager of O T Properties, LLC, owns a parcel of land enclosed on one side by Louisiana Highway 628, also known as River Road. Accordingly the shortest route to a public road would be a road over his property to River Road, which would not increase traffic in CCE.

It should also be noted that The Department of Planning and Zoning states the streets in CCE are not designed to handle the anticipated construction traffic.

The residents of CCE also believe, that without a Drain Impact Analysis for the proposed development, which could negatively affect the drainage system since the proposed land area is higher in elevation than CCE, a predial servitude may exist pursuant to Louisiana Civil Code, as stated in Louisiana Civil Code Article 646. When a predial servitude is established, the dominant estate must use its servitude in a manner that will not unreasonably injure the rights of the servient estate. A dominant estate has a continuing duty not to aggravate the servient estate, and such aggravation includes use of the servitude in a negligent, unauthorized or unreasonable manner.

The Department of Planning and Zoning in their analysis to the application of O T Properties, LLC, states that the Department of Public Works has the same concerns as the residents of County Cottage Estates, as it relates to drainage and the interest of public health, safety and welfare.
