RESOLUTION NO. 6844

A resolution nominating and confirming the appointment of one member who is a resident of St. Charles Parish to the Southeast Louisiana Regional Water Purification Operations Task Force.

WHEREAS, the Louisiana House of Representatives passed its House Resolution No. 305 in the 2025 Regular Session creating a Task Force on Southeast Louisiana Regional Water Purification Operations (the "Task Force"); and,

WHEREAS, the purpose of the Task Force is to study the feasibility of building a water purification facility to service the parishes of Jefferson, Orleans, Plaquemines, St. Bernard, and St. Charles and to provide a written report of findings and recommendations regarding the best strategies and procedures for the operation and management of such facility to the governing authorities of the parishes of Jefferson, Orleans, Plaquemines, St. Bernard, and St. Charles; and,

WHEREAS, the governing authority of the parish of St. Charles shall appoint one member to the Task Force who is a resident of the parish.

NOW, THEREFORE, BE IT RESOLVED, THAT THE MEMBERS OF THE ST. CHARLES PARISH COUNCIL, acting as the governing authority of the Parish of St. Charles shall nominate and confirm the appointment of Mr. Dondi Troxler to the Southeast Louisiana Regional Water Purification Operations Task Force on behalf of the St. Charles Parish Council.
