ORDINANCE NO. 00-8-14

An ordinance to approve and authorize the execution of an Amendment to Ordinance No. 98-4-20 between N-Y Associates, Inc. and St. Charles Parish for an Amendment to the Paul Maillard Road Sidewalk contract for Engineering services.

WHEREAS, Ordinance No. 98-4-20 adopted April 20, 1998, by the St. Charles Parish Council approved and authorized the execution of a contract for engineering services with N-Y Associates, Inc. for necessary Professional Services associated with Paul Maillard Road Sidewalk Project, P970702.

WHEREAS, on July 18, 1995, (Ordinance No. 95-7-2) St. Charles Parish and the Louisiana Department of Transportation and Development entered into a formal agreement to implement the Paul Maillard Road Sidewalk Project which generally consists of constructing sidewalks, approximately 10,000 feet in length, along Route LA 52; and,

WHEREAS, that certain changes in Articles III and IX of the original agreement were needed and St. Charles Parish was agreeable to the changes as set forth in Supplemental Agreement No. 1; and,

WHEREAS, on April 7, 1997, (Ordinance No. 97-4-1) the Parish Council approved and authorized the execution of Supplemental Agreement No. 1; and,

WHEREAS, a resolution authorized the Parish President to execute Supplemental agreement No. 1 to Enhancement Agreement State Project No. 744-45-0002 Federal Aid Project No. ENH-374-1 (006) Paul Maillard Road Sidewalk, Route LA. 52, St. Charles Parish.

WHEREAS, the parish currently has an authorized enhancement project, State Project no. 744-45-0002, F.A.P. No. ENH-374-1 (006);

WHEREAS, the Supplemental Agreement stated the parish would furnish a final set of plans and specifications, using their own engineer at no cost to the program, and 95% of the eligible construction costs would be reimbursed.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS to approve and authorize the execution of an Amendment to Ordinance No. 98-4-20 between N-Y Associates, Inc. and St. Charles Parish for an Amendment to the Paul Maillard Road Sidewalk contract for Engineering Services.

AMENDMENT NO. I
TO
ENGINEERING SERVICES CONTRACT
WITH
N-Y ASSOCIATES
(ORDINANCE NO. 98-4-20)

BE IT KNOWN that on this 29th Day of August, 2000, St. Charles Parish, P.O. box 302, Hahnville, LA. 70057, hereinafter called "Parish", and N-Y Associates, Inc. hereinafter called "Engineer" hereby agree that Ordinance No. 98-4-20 is hereby amended to modify the following provisions:

AMENDMENT TO THE CONTRACT FOR ENGINEERING SERVICES

Paragraph 2.1.2 is hereby amended to read as follows:

2.1.2 In general, the Project consists of the Design and Construction Management of the following major elements of the project:

- Design of sidewalks along the east side of Paul Maillard Road from Highway LA 18 to Highway LA 90.
- Design of ADA compliant pedestrian ramp across the Texas and Pacific railroad tracks.
- Design of drainage improvements along the route required to construct the sidewalks.
- Procuring all applicable permits to construct the sidewalks and the pedestrian ramp.

The amended opinion of probable project budget is as follows:

LADOTD and Railroad Permits	3,000
Engineering, (7.85% of Construction ASCE Curve B)	22,000
Surveying (Fee)	4,500
Grant Coordination	<u>3,000</u>

TOTAL PROJECT BUDGET \$294,147

SECTION II. That the necessary funds for the total project budget in the amount of \$294,147 be allocated to the above-described project and appropriated from the Road and Drainage Maintenance and Operations

All other provisions of said contract shall remain as first written.
