ORDINANCE NO. <u>19-7-4</u>

An ordinance to approve and authorize the execution of a construction contract with Hard Rock Construction, LLC for Parish Project Number P180501, Highway 90 Sinkholes Remediation, in the amount of \$163,955.40.

WHEREAS, two sinkholes developed along Highway 90 due to the failure of two sections of the Parish's existing stormwater drainage system; and,

WHEREAS, sealed bids were received by St. Charles Parish on June 11, 2019, to remediate this section of the Parish's stormwater drainage system; and.

WHEREAS, T. Baker Smith, LLC has reviewed the bids and recommended that the contract be awarded to the lowest responsive bidder, Hard Rock Construction, LLC in the amount of \$163,955.40.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the bid of Hard Rock Construction, LLC, for Parish Project Number P180501, Highway 90 Sinkholes Remediation, is hereby approved and accepted, in the amount of in the amount of \$163,955.40.

SECTION II. That the Parish President is hereby authorized to execute said contract on behalf of the Parish of St. Charles.

SECTION III. A final Notice of Contract shall be printed and filed in place of the contract documents with the St. Charles Parish Clerk of Court and in the records of the St. Charles Parish Council.

PLEASE TAKE NOTICE that by virtue of a written contract dated July 29, 2019, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, Larry Cochran, duly authorized by Ordinance No. 19-7-4, adopted by the St. Charles Parish Council on July 22, 2019, and Hard Rock Construction, L.L.C., 1255 Peters Road, Harvey, LA 70058, through Jason Juneau, Estimator/Member, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct, and complete in a thorough and workmanlike manner: Highway 90 Sinkhole Remediation, Parish Project No. P180501, in St. Charles Parish, Louisiana for the price and sum of ONE HUNDRED SIXTY-THREE THOUSAND, NINE HUNDRED FIFTY-FIVE DOLLARS AND 40/100 (\$163,955.40). The work under the Contract to be completed within forty-five (45) calendar days from the date of the Notice to Proceed.

Said basic work is generally described as follows: rehabilitative construction to remove and replace deficient drainage structures causing (2) sinkholes along Highway 90 in St. Charles Parish according to the Contract Documents prepared by T. Baker Smith, L.L.C., dated and certified March 22, 2019. The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

Principal Work Locations are as follows: Sinkhole 1 is located along Highway 90 on the eastbound side, approximately 0.55 miles from Hahnville High School along the highway. Sinkhole 2 is located similarly along Highway 90 and is approximately 0.25 miles from Hahnville High School along the highway, in St. Charles Parish, Louisiana. Both work locations are within rights-of-way owned by Louisiana Department of Transportation & Development.
