**ORDINANCE NO. 24-8-3**

An ordinance to amend the Code of Ordinances to revise Chapter 15, Motor Vehicles and Traffic, Section 15-9. Speed Limits (a) to provide an exception to the Twenty-five (25) Miles Per Hour Speed Limit, to lower the speed limit on **Fashion Boulevard and Duhe Drive in Fashion Plantation Estates Subdivision, Hahnville, to twenty (20) miles per hour.**

**WHEREAS,** paragraph (a) of Section 15-9 of the Code provides that it is unlawful to operate any motor vehicle at a speed in excess of twenty-five (25) miles per hour on parish streets; and,

**WHEREAS,** that Paragraph (a) of Section 15-9 has been amended to provide exceptions; and,

**WHEREAS,** the Parish Council desires to lower the speed limit on Fashion Boulevard and Duhe Drive in Fashion Plantation Estates Subdivision, Hahnville from twenty-five (25) miles per hour to twenty (20) miles per hour.

**THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:**

**SECTION I.** That Chapter 15 Motor Vehicles and Traffic, Section 15-9. Speed Limits (a) of the Traffic Code is hereby amended as follows, with new text underlined and deleted text in ~~strikethrough~~:

(a) It shall be unlawful for any person to operate any motor vehicle at a speed in excess of twenty-five (25) miles per hour on any of the Parish streets, roads, highways and bridges,

**EXCEPT:**

(94) Fashion Boulevard and Duhe Drive in Fashion Plantation Estates Subdivision, Hahnville, speed limit shall be twenty (20) miles per hour.

The foregoing ordinance having been submitted to a vote, the vote thereon was as follows:
