The new sheet pile wall will be installed as permitted 2' outside the existing timber bulkhead and alignment adjusted due to obstructions determined throughout design.
- Design stop log systems as used on previous phase as necessary for this Phase 2 of the bulkhead.
- Coordinate with both Louisiana Department of Transportation and Development (DOTD) and BNSF Railroad prior to bidding with all limitations determined and described within the plans and specifications.
- Coordinate with necessary utilities to avoid delays during construction.
