An ordinance to approve and authorize the execution of Amendment No. 5 between the Center for Family and Youth Services, Inc. and St. Charles Parish to implement Louisiana Commission on Law Enforcement and Administration of Criminal Justice Subgrant Number A03-8-002.

WHEREAS, St. Charles Parish, in conjunction with the Judges of the 29th Judicial District, the Sheriff's Office, District Attorney's Office and the Schools Drug Free Program applied for a Juvenile Accountability Incentive Block Grant through the Louisiana Commission on Law Enforcement and Administration of Criminal Justice to develop and administer accountability - based sanctions for juvenile offenders; and,

WHEREAS, the Parish was notified that the Commission had set the Grant in the amount of \$48,125.00 Federal Funds with a local cash match of \$10,596.00 for a total of \$58,721.00 for the contract period of October 1, 2004 to September 30, 2005; and,

WHEREAS, the application designated the Center for Family and Youth Services, Inc. as the implementing agency for the Grant; and,

WHEREAS, it is the desire of the Parish and the Center for Family and Youth Services to enter into an agreement for the implementation of Subgrant Number A03-8-002.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That Amendment No. 5 to the Agreement between the Center for Family and Youth Services, Inc. and St. Charles Parish is hereby approved.
