"CONTRACT AMENDMENT NO. 11"



UNITED STATES OF AMERICA STATE OF LOUISIANA PARISH OF ST. CHARLES

BE IT KNOWN, that on the 3rd day of May, 2011, appeared the following:

THE ST. CHARLES PARISH COUNCIL, herein represented by V.J. St. Pierre, Jr., Parish President, hereinafter referred to as "Parish", and

THE ST. CHARLES FIREMEN'S ASSOCIATION, INC., herein represented by its President, Oliver Dufrene, pursuant to a resolution of its Board of Directors dated February 10, 2011, hereafter referred to as "Association",

Who declared that on July 7, 1980, the parties hereto entered into a contract which was adopted by Ordinance No. 80-7-4 and which, in part, allocated certain percentages of sales tax revenues to be apportioned between the fire departments that make up the membership of the St. Charles Firemen's Association, Inc.; and,

That it is the desire of the parties to amend Section (L) of the contract which allocates the monthly base amount and the percentage of remaining funds distribution to the member departments of the Association so that Section (L) will read as follows:

SECTION (L) The funds are to be distributed monthly by the Parish President to the individual members of the Association on the following basis:
