ORDINANCE NO. 02-8-3

An ordinance to revoke and abandon that certain five (5') foot sewer force main on Lots 1B and 2, Square 9, James Business Park, Extension No. 2, St. Charles Parish, State of Louisiana

WHEREAS, certain five (5') servitudes were granted to St. Charles Parish on Lots 1-B and 2, Square 9, James Business Park, Extension No. 2, St. Charles Parish, State of Louisiana, as shown in the Act of Dedication by T. L. James & Co., Inc. pursuant to Ordinance No. 85-7-13; and,

WHEREAS, said servitudes provide no public purpose as evidenced by the letter dated June 27, 2002 from the Department of Public Works/Wastewater; and,

WHEREAS, St. Charles Parish Council desires to revoke said five (5') foot servitudes as provided by law unto the present record owners of the adjacent property.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS, that the Act of Revocation attached hereto and made a part hereof as Exhibit "A" is hereby approved and the St. Charles Parish President is hereby authorized to execute said Act of Revocation.

BEFORE ME, the undersigned Notary Public, duly commissioned and qualified, in and for the Parish of St. Charles, State of Louisiana, therein residing, and in the presence of the witnesses hereinafter named and undersigned;

PERSONALLY CAME AND APPEARED:

ALBERT D. LAQUE, Parish President and Chief Executive Officer of the Parish of St. Charles, herein duly authorized by the provisions of Ordinance No. 02-8-3 , passed and adopted at a meeting of the St. Charles Parish Council held on the 5th day of August, 2002.

That pursuant to the above recited ordinance, the Parish of St. Charles does hereby abandon and revoke the following described servitudes:

- 1) That certain five (5') foot sewer force main servitude over, across and through Lot 1-B, Square 9, James Business Park, Extension No. 2, St. Charles Parish, Louisiana, as shown on the survey of Dading, Marques & Associates, Inc. dated January 6, 2001, said five (5') foot sewer force main recorded at COB 342, folio 353 of the records of the Clerk of Court, Parish of St. Charles, State of Louisiana, and
- 2) That certain five (5') foot sewer force main servitude over, across and through Lot 2, Square 9, James Business Park, Extension No. 2, St. Charles Parish, Louisiana, as shown on the survey of Dading, Marques & Associates, Inc. dated December 15, 2000, said five (5') foot sewer force main recorded at COB 342, folio 353 of the records of the Clerk of Court, Parish of St. Charles, State of Louisiana.

The revocation of the five (5') foot sewer force mains are hereby deemed to be in the best interest of St. Charles Parish as such servitudes do not constitute servitudes utilized or needed by the public.



corner 5 00' 11' 00" W a distance of 393.96 feet to a point;

corner 5 89' 49' 00" W a distance of 552.17 feet to a point on the easterly right of way line of James Drive East;


corner 5 89' 49' 00" W a distance of 393.96 feet to the Point Beginning;
