To the Residents of Bayou Estates South:

Due to public health, safety, and welfare concerns, the street name "Bayou Estates South" must be changed to eliminate confusion with Bayou Estates Drive. A letter was previously sent out in January 2006 to all residents on this street asking for their opinion on changing the street name. The results were as follows: 14 suggested changing the house numbers to be in the 200's, 35 suggested changing the street name, and 13 suggested no change at all. The majority concurred with the changing of the street name, which is currently expected to occur within the next two months.

The Parish Council will be accepting proposed street names from lot owners on this street until April 2, 2008. Please submit your suggestion by filling out and sending the attached form to the Parish Council by the enclosed self addressed stamped envelope or by faxing to 783-2067; Attn: Barbara. A list of suggested names will be compiled from the names submitted by each lot owner. Once compiled, another letter will be sent out to each lot owner listing all suggested street names from which each lot owner shall choose one name. The selected name will need to be forwarded to the Parish Council for compilation. The name receiving the most suggestions will be the name to which the street will be changed.

I would like to apologize in advance for any inconvenience which this may cause. It however is worth it, should it save a life due to an emergency vehicle not being confused with street names and waste valuable time trying to find a resident in distress.

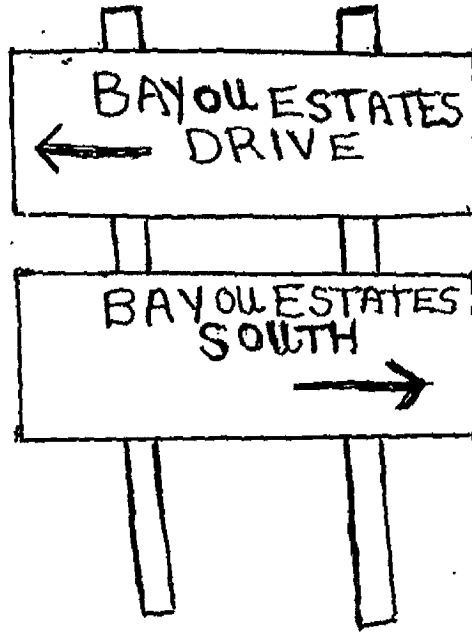

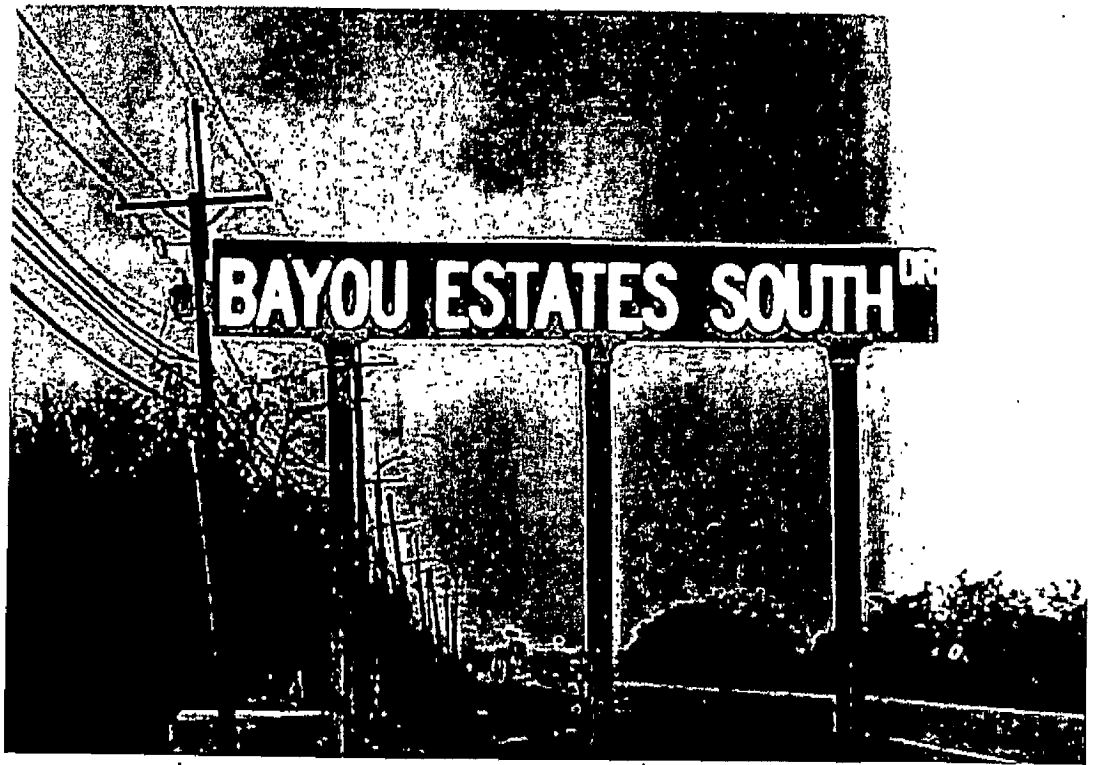




Very large Bayou Estates sign at the

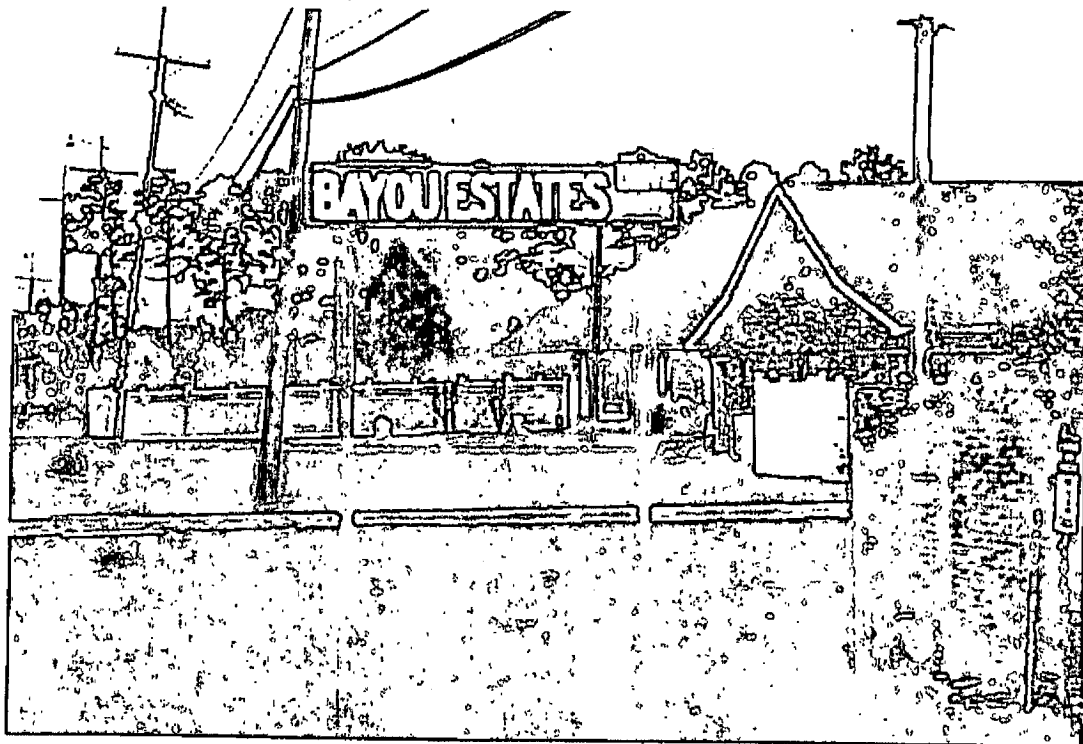
