ORDINANCE NO. 80-6-4

An Ordinance to create the Department of Public Works; provide for its responsibilities and functions; and provide the duties of its Director;

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

WHEREAS; a need exists for the creation of a Department of Public Works; and

WHEREAS; a central system of administration of public works is in the best interest of the Parish; and

WHEREAS; the Home Rule Charter does provide the mechanism for the creation of such departments;

BE IT ORDAINED BY THE ST. CHARLES PARISH COUNCIL, THAT THERE IS HEREBY CREATED THE DEPARTMENT OF PUBLIC WORKS; AND

BE IT ORDAINED THAT THE FUNCTIONS AND RESPONSIBILITIES OF THE DEPARTMENT SHALL BE TO SUPERVISE AND COORDINATE THE FOLLOWING:

- Engineering services for all parish departments, except those specifically provided for.
- 2. All contract construction work.
- Maintenance of Parish properties and general government buildings.
- Maintenance and construction of Parish streets, sidewalks, roads, and bridges.
- 5. Maintenance and construction of Parish drains, ditches and drainage canals.
- 6. Traffic engineering.
- 7. Street cleaning and right-of-way maintenance.
- 8. Trash collection and disposal.
- Operation of central maintenance facilities and equipment.
- 10. Other such duties as may be directed by the Parish President; and

BE IT ORDAINED THAT THE DIRECTOR OF PUBLIC WORKS SHALL BE APPOINTED BY THE PARISH PRESIDENT AS STATED IN ARTICLE III, SECTION C.1.5 OF THE HOME RULE CHARTER, AND THE DIRECTOR'S DUTIES SHALL CONSIST OF CARRYING OUT THE FUNCTIONS AND RESPONSIBILITIES OF THE DEPARTMENT OF PUBLIC WORKS; AND

BE IT FURTHER ORDAINED THAT THIS ORDINANCE SHALL BECOME EFFECTIVE' IMMEDIATELY UPON ADOPTION BY THE COUNCIL AND APPROVAL OF THE PARISH PRESIDENT.
