The tax roll will be certified to the Board of Review on September 17, 2025.

I am hereby requesting that the Parish Council sit as the Board of Review at its October 6, 2025 meeting. Appeals to the Board of Review must be filed no later than 4:00 p.m., Monday, September 29, 2025 in the Parish Council Office.
