ORDINANCE NO. 25-7-9

An ordinance approving and authorizing the execution of a Contract with BLD Services, LLC, for the Ormond CN Railway Culverts Project (Project No. P200801), in the amount of \$10,542,425.00.

WHEREAS, Ordinance No. 20-9-5 adopted on September 21, 2020, by the St. Charles Parish Council, approved and authorized the execution of an engineering services agreement with Barowka and Bonura Engineers & Consultants (BBEC), LLC for providing all necessary services for the Ormond Railroad Culverts Project (P200801) in the amount of \$331,028.00; and,

WHEREAS, sealed bids were received by St. Charles Parish on June 3, 2025, for Ormond CN Railway Culverts Project (Project No. P200801); and,

WHEREAS, Barowka and Bonura Engineers & Consultants (BBEC), LLC has reviewed the bids and recommends that the Contract be awarded to the lowest responsive and responsible bidder, BLD Services, LLC, in the amount of \$10,542,425.00.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the bid of BLD Services, LLC, for the construction of Ormond CN Railway Culverts Project (Project No. P200801), in the amount of \$10,542,425.00 is hereby approved and accepted.

SECTION II. That the Parish President is hereby authorized to execute said Contract on behalf of St. Charles Parish.

SECTION III. A final Notice of Contract shall be printed and filed in place of the contract documents with the St. Charles Parish Clerk of Court and in the records of the St. Charles Parish Council.
