Councilman Hogan,

This email is written in response to St. Charles Parish Council Resolution No. 6289, requesting that DOTD initiate an emergency project to eliminate the hazardous 90 degree curve on LA 632 (WPA Road) in Des Allemands, St. Charles Parish. A field review has been conducted at this location. As you are aware, LA 632 is a two-lane, undivided highway oriented in a general east-west direction and is posted with a 55 mile per hour speed limit. Turn Warning signs with 15 mile per hour advisory speed plaques are installed in both directions of LA 632 in advance of the curve. In addition, Chevron signs and Large Arrow warning signs are also in place to provide guidance to motorists and to further define this curve.

Our office recently conducted spot speed studies along LA 632 at two locations. The principal factor that the Department utilizes to establish a speed zone is the 85th percentile speed. The 85th percentile speed is the speed at which 85 percent of motorists are travelling at or below on a given section of roadway. In addition to the 85th percentile speed, roadside development and geometric alignment are considered when establishing the speed limit. It was determined that motorists are travelling at or slightly above the statutory speed limit, 55 miles per hour, in the section east of the curve. In the section west of the curve, motorists are travelling slightly under the statutory speed limit. Our office will be performing a full speed study to determine if the speed limit should be reduced in the section west of the curve. In the interim, a copy of this email will be forwarded to Captain Donovan Archote, Louisiana State Police Troop B Commander, for his review of the general speeding that was observed during the field review.

This office also reviewed crash records that were provided by the Louisiana State Police and St. Charles Parish Sheriff's Office. While there were some crashes that were documented along LA 632, there was no significant pattern of accidents noted. The crash records do verify that a crash, referenced in the resolution, occurred involving an overturned 18-wheeler in February 2017. A turning radius evaluation confirmed that larger commercial vehicles may have difficulty maneuvering through the curve. By copy of this email, it is recommended that Mr. Ennis Johnson, Assistant District Administrator-Engineering, investigate the feasibility of improving the alignment of this curve through a construction project.
