An ordinance to approve and authorize the execution of a contract with Pintail Contracting Services, LLC for West Bank A Plant Filter Upgrade (Project No. WWKS 97) in the amount of \$394,304.00.

- WHEREAS, Ordinance No. 18-6-6 adopted June 4, 2018, by the St. Charles Council, approved and authorized the execution of a contract for engineering services with Design Engineering, Inc. for engineering services with the West Bank A Plant Filter Upgrade (WWKS 97); and,
- WHEREAS, sealed bids were received by the Parish on May 25, 2021, for the West Bank A Plant Filter Upgrade (Project No. WWKS 97); and,
- WHEREAS, Design Engineering, Inc., the engineer for the project has reviewed the bids and recommend that the contract be awarded to the low bidder, Pintail Contracting Services, LLC, of Luling, LA, in the amount of \$394.304.00;
- WHEREAS, the upgrade will improve filter efficiency and the quality of drinking water being produced for the citizens of St. Charles Parish.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the bid of Pintail Contracting Services, LLC for the West Bank A Plant Filter Upgrade (Project No. WWKS 97) is hereby approved and accepted in the amount of \$394,304.00.

SECTION II. That the Parish President is hereby authorized to execute said contract on behalf of St. Charles Parish.

SECTION III. A final Notice of Contract shall be printed and filed in place of the contract documents with the St. Charles Parish Clerk of Court and in the records of the St. Charles Parish Council.

PLEASE TAKE NOTICE that by virtue of a written contract dated August 24, 2021, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, Matthew Jewell, duly authorized by Ordinance No. 21-8-12 adopted by the St. Charles Parish Council on August 23, 2021 and Pintail Contracting Services, LLC, 13559 River Road, Luling, LA 70070, through Jeffery Lemoine, Jr., Owner, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct, and complete in a thorough and workmanlike manner: West Bank A Plant Filter Upgrade, (Project No. WWKS 97), in St. Charles Parish, Louisiana for the price and sum of THREE HUNDRED NINETY-FOUR THOUSAND, THREE HUNDRED FOUR AND 00/100 (\$394,304.00) DOLLARS, the work under the Contract to be completed within one hundred twenty (120) calendar days from the date of the Notice to Proceed.

Said basic work consists of installing new filter underdrain systems, filter media, and replacing leaded joints and existing piping, according to the Contract Documents prepared by Design Engineering, Inc., dated and certified April 26, 2021.

The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Applications for Payment in accordance with Article 15 of the General Conditions. The complete Contract Documents may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

Principal Work Location is in the vicinity of 403 Milling Avenue, in Luling, St. Charles Parish, Louisiana. All of the work of this Contract is located in rights-of-way owned and/or granted right to use by St. Charles Parish.
