

NOTICE OF CONTRACT

PLEASE TAKE NOTICE that by virtue of a written contract dated July 14, 2017, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, Larry Cochran, duly authorized by Ordinance No. 17-7-6 adopted by the St. Charles Parish Council on July 10, 2017, and Fleming Construction Company, L.L.C 23 East Airline Drive, Kenner, LA 70062, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct, and complete in a through and workmanlike manner the LA 18 Cast Iron Replacement, Phase II in St. Charles Parish, Louisiana for the price and sum of **FOUR HUNDRED SEVENTY-THREE THOUSAND EIGHT HUNDRED EIGHTY-EIGHT DOLLARS AND 00/100THS (\$473,888.00) DOLLARS**, the work under the Contract to be completed within (150) one hundred and fifty calendar days from the date of the Notice to Proceed. Said basic work is the design, fabrication, and construction of a new waterline to replace the existing cast iron system and include all improvements as shown on the Drawings, Specifications and Contract Documents for LA 18 Cast Iron Replacement, Phase II, as prepared by Civil and Environmental Consulting Engineers dated and stamped on January 19, 2017. The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents and Specifications may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

The property upon which the above described improvements are to be constructed is located along LA 18 from approximately Courthouse Lane to Fashion Plantation Boulevard, in Hahnville, Louisiana, in St. Charles Parish. All of the work of this Contract is located in rights-of-way owned and/or granted right to use by St. Charles Parish.
