**WHEREAS,** it was discussed that filling out preliminary reports has the effect of the Council having to ask for permission to travel; and,

**WHEREAS,** it was discussed that the filling out reports is nicky-picky stuff; and,

**WHEREAS,** it was discussed that these reports are childish and ridiculous; and,

**WHEREAS,** it was discussed that we are all grown-ups and that we have Ethics Laws by which we have to live by, and other laws which dictate how Government money, public funds, etc. can be spent; and,
