

NOTICE OF CONTRACT

PLEASE TAKE NOTICE that by virtue of a written contract dated February 4, 2015, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, V. J. St. Pierre, Jr., duly authorized by Ordinance No. 15-1-8 adopted by the St. Charles Parish Council on January 26, 2015 and Industrial & Mechanical Contractors, Inc. 757 Central Avenue, Jefferson, LA 70121 through Harry Heidingsfelder, President, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct and complete in a thorough and workmanlike manner the Mimosa Park Drainage Improvements in St. Charles Parish, Louisiana for the price and sum of SEVEN HUNDRED THIRTY FIVE THOUSAND ONE HUNDRED FIFTY SIX DOLLARS AND 00/50 (\$735,156.50) DOLLARS, the work under the Contract to be completed within one hundred eighty (180) calendar days from the date of the Notice to Proceed. Said basic work to include replacing existing culverts with new culverts at five locations along Ellington Canal between Monsanto Drive and Lagattuta Drive, the installation of a new drainage pumping station including a 12' X 15' reinforced concrete wet well, two 24" axial flow propeller pumps with 75HP motors, 30" welded steel discharge piping, and all associated site and electrical work; and capacity improvements to the existing drainage system including the installation of 1138 LF of 48" storm drainage pipe, 12 catch basins, 8 junction boxes, 478 LF of ditch grading, and a concrete flume with bar screen; and all associated demolition and restoration work; as shown on the Drawings, Specifications and Contract Documents for the Mimosa Park Drainage Improvement Project No. P090904 as prepared by Buchart Horn, Inc. on October 22, 2014. The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents and Specifications may be reviewed at the


