ORDINANCE NO. 22-7-8

An ordinance to amend Ordinance No. 21-4-5 to approve an Act of Correction to show the servitude area through Lot 83 on the Final Plat of River Road Estates Subdivision Phase I, Hahnville, St. Charles Parish, LA.

WHEREAS, on April 5, 2021, the St. Charles Parish Council adopted Ordinance No. 21-4-5 approving and authorizing the execution of an Act of Dedication by River Road Estates, LLC for River Road Estates Subdivision, Phase 1, Hahnville, as shown on a plat entitled A FINAL PLAT OF RIVER ROAD ESTATES SUBDIVISION PHASE I, by Ralph P. Fontcuberta, Jr., PLS, dated March 5, 2021, with "1" and "I" used interchangeably; and,

**WHEREAS**, it has been determined that the original plan was in error in that the servitude area of Lot 83 was drawn incorrectly; and,

WHEREAS, it is the desire of the developer, through his surveyor, and of the Parish Council to correct the error by the adoption of an "Act of Correction."

## THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

**SECTION I.** That Ordinance No. 21-4-5 adopted on April 5, 2021, is hereby amended by the Act of Correction document by Ralph P. Fontcuberta, Jr. PLS dated June 13, 2022, and the plat, also by Ralph P. Fontcuberta, Jr. PLS dated June 15, 2022, and stamped June 27, 2022, entitled AN ACT OF CORRECTION TO THE FINAL PLAT OF RIVER ROAD ESTATES SUBDIVISION PHASE 1 WITH THE CORRECT SERVITUDE DIMENSIONS FOR LOT 83.

**SECTION II.** That the Parish President is hereby authorized to execute said Act of Correction and revised final plat on behalf of St. Charles Parish.
