ORDINANCE NO. 23-3-4

An ordinance approving and authorizing the execution of a contract with Pintail Contracting Services, LLC, for the East Bank "C" Plant Filter Upgrade (Project No. WWKS-96) in the amount of \$2,023,900.00.

WHEREAS, Ordinance No. 18-6-5 adopted on June 4, 2018, by the St. Charles Parish Council, approved and authorized the execution of a contract for Engineering Services between St. Charles Parish and GSA Consulting Engineers to perform engineering services for Project No. WWKS-96; and,

WHEREAS, Ordinance No. 21-5-5 adopted on May 3, 2021, by the St. Charles Parish Council, approved and authorized Amendment No.1 to Ordinance No. 18-6-5; and,

WHEREAS, Resolution No. 6572 adopted on July 26, 2021, by the St. Charles Parish Council approved McKim & Creed, Inc. as assignee in title of GSA Consulting Engineers in connection with the Engineering Services Contract with GSA Consulting Engineers, for the East Bank C Plant Filter Upgrade (WWKS-96); and,

WHEREAS, sealed bids were received by the Parish on December 15, 2022, for the East Bank "C" Plant Filter Upgrade (Project No. WWKS-96); and,

WHEREAS, McKim & Creed, Inc. has reviewed the bids and recommend that the Contract be awarded to the low bidder, Pintail Contracting Services, LLC, in the amount of \$2,023,900.00.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the bid of Pintail Contracting Services, LLC, for the East Bank "C" Plant Filter Upgrade (Project No. WWKS-96) is hereby approved and accepted in the amount of \$2,023,900.00.

SECTION II. That the Parish President is hereby authorized to execute said contract documents on behalf of St. Charles Parish.

SECTION III. A final Notice of Contract shall be printed and filed in place of the contract documents with the St. Charles Parish Clerk of Court and in the records of the St. Charles Parish Council.

NOTICE OF CONTRACT

PLEASE TAKE NOTICE that by virtue of a written contract dated April 3, 2023, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, Matthew Jewell, duly authorized by Ordinance No. 23-3-4 adopted by the St. Charles Parish Council on March 27, 2023, and Pintail Contracting Services, LLC, 13559 River Road, Luling, 70070, through Jeffery J. Lemoine, Jr., Owner, entered into a contract to furnish all labor and materials and perform the work required to build, construct, and complete in a thorough and workmanlike manner in connection with the following: East Bank "C" Plant Filter Upgrade, SCP Project Number WWKS-96, in St. Charles Parish, Louisiana, for the price and sum of TWO MILLION TWENTY-THREE THOUSAND, NINE HUNDRED, AND 00/100, (\$2,023,900.00), the work under the Contract to be completed within two hundred forty (240) calendar days from the date of the Notice to Proceed.

Said basic work is generally described as follows: the removal, disposal, and replacement of the "C" Plant washtroughs and associated hardware, filter media, siphons, vacuum pumps, piping from the vacuum tank to the inlet and backwash siphons, 6" water supply piping, surface sweep rotating bearings, and effluent weir and guide channels. It also includes the removal, disposal, and replacement of the operating and access platforms (to include handrails and kickplates), as well as the filter floor system, which will be replaced with the Monoflor 1200 HD System. Other work includes pressure washing and roll painting the inside of the "C" Plant Filter building, removal/replacement of various electrical conduits, removal and disposal of metal frames/doors and exhaust fans and respective replacement with fiberglass frames and doors and new exhaust fans, masonry repair, miscellaneous concrete repair within filter, and miscellaneous metals. For exact details, refer to Plans and Specifications for full scope, according to the Contract Documents prepared by McKim & Creed, Inc. dated and certified October 21, 2022.

The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Applications for Payment in accordance with Article 15 of the General Conditions. The complete Contract Documents may be reviewed at the Records Office of the St. Charles Parish Council, 3rd floor, Parish Courthouse, 15045 River Road, Hahnville, LA.

Principal Work Location: East Bank Water Treatment Plant, 14924 River Road, New Sarpy, LA 70078. All of the work of this Contract is located in rights-of-way owned and/or granted right to use by St. Charles Parish.
