ORDINANCE NO. 20-6-5

An ordinance to approve and authorize the execution of a contract with Wallace C. Drennan, Inc. for the East Bank Transmission Line Repair/Replacement (Project No. WWKS 101) in the amount of \$433,000.00.

WHEREAS, sealed bids were received by the Parish on April 23, 2020, for the East Bank Transmission Line Repair/Replacement (Project No. WWKS 101); and,

WHEREAS, Shread-Kuyrkendall & Associates, Inc. has reviewed the bids and recommend that the Contract be awarded to the low bidder, Wallace C. Drennan, Inc. in the amount of \$433,000.00.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the bid of Wallace C. Drennan, Inc. for the East Bank Transmission Line Repair/Replacement (Project No. WWKS 101) be hereby approved and accepted in the amount of \$433,000.00.

SECTION II. That the Parish President is hereby authorized to execute the said contract documents on behalf of St. Charles Parish.

SECTION III. A final Notice of Contract shall be printed and filed in place of the contract documents with the St. Charles Parish Clerk of Court and in the records of the St. Charles Parish Council.

NOTICE OF CONTRACT

PLEASE TAKE NOTICE that by virtue of a written contract dated June 3, 2020, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, Matthew Jewell, duly authorized by Ordinance No. 20-6-5, adopted by the St. Charles Parish Council on June 1, 2020, and Wallace C. Drennan, Inc., P.O. Box 15438, New Orleans, LA 70175-5438, through Wallace C. Drennan, III, President, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct, and complete in a thorough and workmanlike manner: Project No. WWKS 101, East Bank Transmission Line Repair/Replacement, in St. Charles Parish, Louisiana for the price and sum of FOUR HUNDRED, THIRTY-THREE THOUSAND DOLLARS AND 00/100 (\$433,000.00). The work under the Contract to be completed within Ninety (90) calendar days from the date of the Notice to Proceed.

Said basic work consists of excavation to access an existing East Bank 24" Transmission Line of approximately 2000 feet for television inspection, preparing, and sliplining with a 20" HDPE DR 17 new line, and tying the new line back into the existing 24" DI waterline; Mechanical Cleaning/Descaling is an alternate, if deemed necessary for additional cleaning, according to the Contract Documents prepared by Shread-Kuyrkendall & Associates, Inc., dated and certified February 14, 2020. The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

Principal Work Location generally at New Sarpy, in St. Charles Parish, Louisiana. All of the work of this Contract is located in rights-of-way owned and/or granted right to use by St. Charles Parish.




