**ORDINANCE NO. 25-12-3**

An ordinance to provide for the installation of an "ALL-WAY STOP" sign at the end of Pitre Street in the Fairfield Oaks Plantation Subdivision, in St. Rose.

**WHEREAS**, the St. Charles Parish Code of Ordinances, Chapter 15 Motor Vehicles and Traffic provides for the installation of traffic control signs; and,

**WHEREAS**, the installation of an "All-Way Stop" sign will significantly reduce the possibility of accidents at this intersection by mitigating the risk navigating at the end of Pitre Street; and,

**WHEREAS**, it is the desire of the Parish Council to authorize the installation of an "ALL-WAY STOP" sign at the end of Pitre Street in the Fairfield Oaks Plantation Subdivision, in St. Rose, due to safety concerns.

**THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:**

**SECTION I.** That there is hereby established an "ALL-WAY STOP" sign at the end of Pitre Street in the Fairfield Oaks Plantation Subdivision, in St. Rose.

**SECTION II.** That the Department of Public Works is hereby authorized to erect and maintain said "ALL-WAY STOP" sign.
