

NOTICE OF CONTRACT

WILLOWRIDGE LEVEE – PHASE I

PLEASE TAKE NOTICE that by virtue of a written contract dated November 19, 2013, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, V. J. St. Pierre, Jr., duly authorized by Ordinance No. 13-11-6 adopted by the St. Charles Parish Council on November 18, 2013 and Southern Delta Construction, LLC Post Office Box 309 Bourg, LA 70343 through Michael Mayeux, Vice President, entered into a contract to furnish labor, materials and equipment for the construction of the Willowridge Levee Phase 1 in St. Charles Parish, Louisiana for the price and sum of FIVE MILLION SEVEN HUNDRED EIGHTY FIVE THOUSAND, FIVE HUNDRED FIFTY ONE AND 00/100THS (\$5,785,551.00) DOLLARS, the work under the Contract to be completed within Three Hundred Sixty Five (365) calendar days from the date of the Notice to Proceed. Said basic work to include the construction of all improvements as shown on the Drawings, Specifications and Contract Documents for Parish Project No. P080905-3B, Willowridge Levee Phase 1, as prepared by Burk-Kleinpeter, Inc., dated June 2013 and stamped on June 27, 2013. The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents and Specifications may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

The property upon which the above described improvements are to be constructed is generally described as the Willowridge Levee – Phase 1 in St. Charles Parish, located in Luling, as per the detailed plans and specifications prepared by Burk-Kleinpeter, Inc.
