RE:

Ms. Jena Troxler made a presentation to us at a Parish Council Meeting in May informing us of the activities at the Animal Shelter. Since her addressing us, I have finally had time to be able to do something I have wanted to do for years. That is to obtain and review the Parish ordinances and its agreement with the Humane Society and understand how the operation works. The information provided to me by our Council Secretary shows that there has been five (5) amendments to the original Agreement. Please review the attached and let me know if there are any our Secretary has missed. I have taken the amendments provided to me and added them to the original Agreement. Attached you will find what I see as the current form of the Agreement. Please review and let me know if this document represents the extent of the current Agreement the Parish has with the Humane Society. In the Agreement, Item 12 states there could be other services that the Parish President could agree to. Please let me know if there are any other services that you or any other Parish President had agreed to. Please send me a copy of them if there are any.

The Agreement also shows that the Parish has certain responsibilities and the Humane Society has certain responsibilities and that dollars comes into play with some. Item 1 shows that a fee of \$80 is collected by the Society for each animal adopted. Item 2 says the Society is to use the adoption fee to offset their cost to spay adopted animals in St. Charles Parish. From what Ms. Troxler informed the Council in May, I understood her to say that she was now performing the spaying instead of the Society. Please confirm if that is correct, and if it is, then it appears that the Agreement needs to be amended to account for this and to account for the \$80 fee collected and where this money is to go since it was to go to the Society for them to do the spaying. Item 7(a) also needs to be looked at since it refers to veterinarian assistance on Tuesdays. With what Ms. Troxler stated, is this veterinarian assistance still needed or applicable?

With Item 13, are the adoption records being sent to the Parish (the Council?) on a monthly basis? I do not recall ever seeing any during my time on the Council.

With Item 22, the Society agrees to pay for the medical care of injured animals when they are consulted and give their prior approval for the care. I would assume the care was done by outside vets before Ms. Troxler came on board and is now being taken care of by her. Is that correct? I would assume the Society is not being contacted to get approval to pay for the medical care of injured animals since Ms. Troxler can do the service, which I would assume she is now doing. Is that correct? With respect to the money that the Society would use to pay for this, was those dollars, funds, which came from St. Charles Parish by some means to pay for this and is now being collected by them and not being spent back on us for this service? Please advise. Also, what about animals that come in that have a problem other than needing to be spayed or a problem but not due to an injury. How do animals with these other issues get treatment? Does our Agreement with the Society or our code provides for them getting attention or are do those animals just get put down? Does Ms. Troxler do surgeries on animals that come in that have issues other than injuries or spaying? Please advise.

Item 23 refers to the Society possibly assisting the Parish with the rabies vaccination program if it gets prior approval of the Parish President. Do we have a rabies vaccination program and have you or a prior Parish president given approval for this? If yes, how does it work and please send me documentation of this for my files.

In reviewing our related Parish ordinances, it looks like there is one part in there that has the possibility of some generation of funds with regards to the "Disposal for medical or scientific experimentation" (Sec. 4-53). What happens to the carcasses of animals that are euthanized? Are they given away, disposed of by some means, or do medical or scientific related entities pay for them? Please explain what happens to them and if we do get funds for them by some means, how do we use these funds?

And in general, please have the entire Agreement with the Society reviewed and see if everything in there is still applicable or if there are some things that no longer apply or needs amending here and there.

Also, please review Chapter 4 – Animals and Fowl and see if there are any changes needed in this Section of the code to account for anything that we may be doing that we should not be doing. Please advise if we need to add something that we should be doing that our code does not allow us to do, or if the code needs any amending as it relates to the job of the Animal Shelter and the Humane Society.

To process all adoptions and utilize the Adoption Fee provide herein to offset the cost to spaying adopted animals of St. Charles Parish.

- 3.) An annual financial report of the adoption account shall be sent to the Parish for review and approval. Funds from the account shall only be used for the purpose for which St. Charles Humane Society was established. Proposed usage of these funds shall be written and provided to St. Charles Parish for review by the St. Charles Parish Legal Services Department and approval by the St. Charles Parish President. This section shall apply to those funds generated from the adoption fee and shall have no effect on other monies generated by the St. Charles Humane Society from other sources. The financial report shall be submitted to St. Charles Parish no later than January 31st of each year that this agreement is in effect.
  - 4) St. Charles Amane Society shall use the adoption agreement as approved by the Director of Legal Services. Prior written approval by the Director of Legal Services shall be required for any proposed changes or modifications made to the adoption agreement.
  - 5) The St. Charles Humane Society shall not assign or transfer any interest in the agreement without prior written consent of the Parish Council.
- 6) The St. Charles Humane Society shall forward a copy of their Certificate of Insurance as well as a copy of a Certificate of Insurance from any veterinarians who volunteers to assist the Humane Society in the adoption program prior to the commencement of this agreement. No less than fifteen days prior to the expiration date of the said insurance the Humane Society shall show proof of insurance renewal. St. Charles Parish should be notified immediately of cancellation of insurance. This insurance shall be a minimum of \$500,000.00 Liability coverage for all acts of its members.
- 7.) St. Charles Parish shall allow members of the St. Charles Humane Society to assist at the Animal Control Facility with pet care and adoptions on Wednesday and Saturday of each week between the hours of 12:00 P.M. and 3:00 P.M.

a) Veterinarians assistance on Tuesday of each week between the hours of 12:00 P.M. and 3:00 F.M.

- b) Pet growing and adoptions on Wednesday of each week during normal working hours.
- c) Pet growing and adoptions on Saturday of each week between the hours of 12:00 P.M. and 3:00 P.M.
- 8) The St. Charles Parish Humane Society shall provide St. Charles Parish with a roster of all members including addresses and phone numbers. Rosters shall be updated on a monthly basis. Said roster's only purpose shall be for varifying membership by Parish Animal Control Personnel. Said roster shall not be considered as public record and shall not be distributed by Parish personnel to anyone unless so ordered by the Courts. Only members whose names appear on the roster will be allowed to work in the Animal Control Facility. In the absence of Parish personnel at least one elected officer of the Humane Society shall be present and responsible for the Animal Control Facility.
- 9) St. Charles Parish shall make available five (5) dog holding areas and four (4) dat holding areas to house the pets selected by the St. Charles Humane Society for adoption.
- 10.) No animal shall be selected for adoption until all holding time requirements of the St. Charles Parish Animal Control Code have been met in accordance with Animal Control Identification Cards placed on each animal cage and/or. kennel run. THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. That the St. Charles Humane Society is hereby authorized to coordinate and establish an Adoption Program through the Animal Control Office for all unclaimed animals picked up by the Parish, in accordance with the attached Agreement.

SECTION II. That the Parish President is hereby authorized to execute the attached Agreement on behalf of St. Charles Parish.

SECTION III. That Ordinance No. 83-3-2 adopted by the Charles Parish Council on March 7, 1983, is hereby rescinded. The foregoing ordinance having been submitted to a vote, the
