ORDINANCE NO. 04-4-19

An Ordinance to amend the 2004 Consolidated Operating and Capital Budget to: provide for the increase in the Registrar of Voters Employees' Retirement System's employers portion; in the Emergency Preparedness Subsidiary's budget to rollover funds for "EOC Operations Room Upgrade" that were budgeted in 2003, to provide funds for uniforms and identification for the Parish Rapid Assessment Team as specified by the Bayou/River Parish Mutual Aid and Assistance Taskforce; and to provide funds in EOC-24 Hour Coverage for the hiring of an additional Communications Operator; and adjust General Fund revenues to provide for the increase in Entergy's annual support payments.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

WHEREAS, the 2004 St. Charles Parish Consolidated Operating and Capital Budget was adopted by Ordinance No. 03-11-4 on November 6, 2003; and;

WHEREAS, the Council has taken under consideration the study of the amendment to the St. Charles Parish Consolidated Operating and Capital Budget for fiscal year 2004 as shown by the Revision Schedule.

NOW, THEREFORE, in accordance with the provisions of Article V, Sections D, E, and F of the St. Charles Parish Home Rule Charler and with the Louisiana Local Government Budget Act (R.S. 39:1301 et. seq.), the St. Charles Parish Council does hereby ordain to adopt the 2004 St. Charles Parish Consolidated Operating and Capital Budget as amended, and that it be attached hereto and made a part hereof and identified as "Exhibit A".
