An ordinance to approve and authorize the execution of a contract with Barriere Construction Co., LLC for the Maintenance Contract of Parish Project No. P210302 Asphalt Pavement Maintenance, with Bid in the amount of \$2,563,450.00.

WHEREAS, sealed bids were received by St. Charles Parish on April 13, 2021 for P210302 Asphalt Pavement Maintenance; and,

WHEREAS, St. Charles Parish Department of Public Works/Wastewater, have reviewed the bids and recommend that the Bid of the Maintenance Contract be awarded to the low bidder, Barriere Construction Co., LLC, in the amount of \$2,563,450.00.

PLEASE TAKE NOTICE that by virtue of a written contract dated May 24, 2021, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, Matthew Jewell, duly authorized by Ordinance No. 21-5-12 adopted by the St. Charles Parish Council on May 17, 2021, and Barriere Construction Co., LLC, P.O. Box 1576 (1268 LA 3127), Boutte, LA 70039, through Jason P. Latiolais, Vice President – Asphalt Operations, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct, and complete in a thorough and workmanlike manner: Asphalt Pavement Maintenance, Project No. P210302, in St. Charles Parish, Louisiana. The value of this contract (combined value of task orders) will not exceed TWO MILLION, FIVE HUNDRED SIXTY-THREE THOUSAND, FOUR HUNDRED FIFTY AND 00/100 (\$2,563,450.00) DOLLARS. The Owner will pay and the Contractor will accept in full consideration for the performance of the Contract pursuant to the following: an amount equal to the sum of the established unit price for each separately identified item of Unit Price Work times the actual quantity of that item performed under each Task Order. Contract price is firm and subject only to modification by written Change Order agreed to and signed by both parties and the Engineer and approved by the St. Charles Parish Council.

The Contract will expire at the final payment for the last Task Order issued in 2021. No Task Order may be issued after December 31, 2021. Contractor shall complete all of the Work under any Task Orders within the stated time associated with each Task Order.

Said basic work is described as follows: asphalt street pavement rehabilitation according to the Contract Documents prepared by Miles B. Bingham, P.E., dated March 17, 2021 and certified May 20, 2021.

Contractor shall submit Applications for Payment to the engineer in accordance with Article 15 of the General Conditions. The complete Contract Documents may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

Principal Work Location is Parish-Wide, St. Charles Parish, Louisiana. All of the work of this Contract is located in rights-of-way owned and/or granted right to use by St. Charles Parish.
