**ORDINANCE NO:** 25-8-8

An ordinance approving and authorizing the execution of Amendment No. 1 to Ordinance No. 19-9-6, which approved the Engineering Services Contract with Shread-Kuyrkendall & Associates, Inc. for the Lakewood Drive Reconstruction (Project No. P190201), to increase the construction and closeout amount by \$80,000.00 for a new not to exceed amount of \$280,000.00, increasing the overall contract amount to \$799,380.24.

**WHEREAS,** Resolution No. 6504 adopted on June 15, 2020, by the St. Charles Parish Council, approved requesting the Louisiana Department of Transportation & Development perform a study to determine the feasibility of the installation of a right turn lane on Lakewood Drive, Luling, in conjunction with protected left turn signal phases, pavement markings, and directional signage at its intersection with U.S. Highway 90 and Barton Avenue (LA 3060), to reflect and further enhance the traffic management improvements recently installed at U.S. Highway 90 and Barton Avenue (LA 3060), and further request installation of traffic revisions if said study determines revisions are warranted; and,

**WHEREAS,** Ordinance No. 19-9-6 adopted on September 23, 2019, by the St. Charles Parish Council, approved and authorized the execution of an Engineering Services Contract with Shread-Kuyrkendall & Associates, Inc. for the design of Parish Project No. P190201, Lakewood Drive Reconstruction in the estimated amount of \$328,479.92; and,

**WHEREAS,** Ordinance No. 21-1-1 adopted on January 11, 2021, by the St. Charles Parish Council, approved and authorized the execution of an Agreement with the Louisiana Department of Transportation and Development (DOTD), for Parish Project No. P190201 Lakewood Drive Reconstruction State Project No. H.014051, Federal Aid Project No. H014051; and,

**WHEREAS,** Ordinance No. 23-4-5 adopted on April 10, 2023, by the St. Charles Parish Council, approved and authorized the execution of a Contract with Byron E. Talbot Contractor, Inc., for the construction of the Lakewood Dr. Reconstruction, State Project No. H.014051, Federal Aid Project No. H014051, extending from East/West Heather Dr. to Highway 90 in the amount of \$5,979,591.63; and,

**WHEREAS,** Ordinance No. 23-5-7 adopted on May 22, 2023, by the St. Charles Parish Council, approved and authorized the execution of a Professional Services Agreement with Gulf South Engineering and Testing, Inc., to perform testing services for Lakewood Dr. Reconstruction State Project No. H.014051, Federal Aid Project No. H014051 (Project No. P190201) in a not to exceed amount of \$60,100.00; and,

**WHEREAS,** while the project is constructed, it is necessary to perform extensive closeout procedures for compliance with the Louisiana Department of Transportation and Development; and,

**WHEREAS,** St. Charles Parish and Shread-Kuyrkendall & Associates, Inc. have mutually agreed to increase the construction and closeout amount by \$80,000.00 for a new not to exceed amount of \$280,000.00, increasing the overall contract amount to \$799,380.24.

**THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:**

**SECTION I.** That Amendment No. 1 to the Engineering Services Contract with Shread-Kuyrkendall & Associates, Inc. for the Lakewood Drive Reconstruction (Project No. P190201), to increase the construction and closeout amount by \$80,000.00 for a new not to exceed amount of \$280,000.00, increasing the overall contract amount to \$799,380.24 is hereby approved and accepted.

**SECTION II.** That the Parish President is hereby authorized to execute said Amendment on behalf of St. Charles Parish.

ENGINEERING SERVICES FOR LAKEWOOD  
DRIVE RECONSTRUCTION (PARISH  
PROJECT NO. P190201)**

THIS AMENDMENT NO. 1 is made and entered into on this

BY AND BETWEEN:

**ST. CHARLES PARISH**, represented herein by its duly authorized Parish President, Matthew Jewell, (hereafter sometimes referred to as “OWNER”), and

**Shread-Kuyrkendall & Associates, Inc.** represented herein by Ripley McClure, duly authorized by Corporate Resolution attached hereto (hereafter sometimes referred to as “Engineer”):

**WHEREAS**, on June 15, 2020, St. Charles Parish Council approved Resolution No. 6504 to request Louisiana Department of Transportation and Development to perform a study for the installation of a right turn lane on Lakewood Drive, pavement markings, signal phases and directional signage at the intersection of Lakewood Drive, Barton Ave, and Highway 90; and,

**WHEREAS**, on September 23, 2019, the St. Charles Parish Council approved Ordinance No. 19-9-6; to authorize an Agreement with Shread Kuykendall & Associates, Inc., for the design and subsequent bidding of Lakewood Drive Reconstruction (Project No. P190201) in the estimated amount of \$328,479.92; and,

**WHEREAS**, on January 11, 2021, St. Charles Parish Council approved Ordinance No. 21-1-1 authorizing an Agreement with the Louisiana Department of Transportation and Development for Lakewood Drive Reconstruction (Project No. P190201) (State Project No. H.014051, Federal Aid Project No. H014051); and,

**WHEREAS**, on April; 10, 2023, St. Charles Parish Council approved Ordinance No. 23-4-5 authorizing a contract with Byron E. Talbot Contractor, Inc. for the construction of Lakewood Drive Reconstruction (Project No. P190201) (State Project No. H.014051, Federal Aid Project No. H014051) in the amount of \$5,979,591.63; and,

**WHEREAS**, on May 22, 2023, St. Charles Parish Council approved Ordinance No. 23-5-7 to authorizing and Agreement with Gulf South Engineering and Testing, Inc., for necessary testing for Lakewood Drive Reconstruction (Project No. P190201) (State Project No. H.014051, Federal Aid Project No. H014051) in the not to exceed amount of \$60,100.00; and,

**WHEREAS**, While the project is constructed, it is necessary to perform extensive closeout procedures for compliance with the Louisiana Department of Transportation and Development.

**WHEREAS**, St. Charles Parish and Shread-Kuyrkendall & Associates, Inc. have mutually agreed to increase the current Construction and Closeout amount of \$200,000.00 by a not to exceed fee of \$80,000.00 which will result in a total contract cost of \$799,380.24.

- 5.1     The Owner reserves the right to request Engineer to provide Additional Engineering and/or Additional Services described in Section 5, Paragraphs 5.1.1 through 5.1.2.12 inclusive. It is mutually understood that the Owner reserves the right to reevaluate any/all interested Engineering Firms concerning Additional Engineering or Additional Services as described in Section 5.0. The Owner shall issue written authorization to the Engineer to provide Additional Engineering and/or Additional Services prior to the performance of any Additional Engineering and/or Additional Services as described in Section 5, Paragraph 5.1 through 5.1.2.12 inclusive.

**Add Section 5.1.2.12**

- 5.1.2.12     Provide Closeout in compliance with policies of Louisiana Department of Transportation and Development. Parish has negotiated an additional \$80,000 to Construction and Closeout with the ENGINEER. This will make the Construction and Closeout increase to a total not to exceed amount of \$280,000.00.

## CORPORATE RESOLUTION


