ORDINANCE NO. 86-7-8

An ordinance to create the Department of Sewerage; provide for its responsibilities and functions, and provide for the duties of its director.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

WHEREAS, a need exists for the creation of a Department of Sewerage, and

WHEREAS, a central system of administration of parish sewer services is in the best interest of the parish, and

WHEREAS, the Home Rule Charter does provide the mechanism for the creation of such departments.

NOW, THEREFORE, BE IT ORDAINED BY THE ST. CHARLES PARISH COUNCIL:

SECTION 1. That there is hereby created the Department of Sewerage, and

SECTION II. That the functions and responsibilities of the Department of Sewerage shall be to:

- a. Operate and maintain all parish-owned sewerage facilities and properties including collection systems, treatment plants, oxidation ponds, buildings and other appurtenant items.
- **b.** Supervise and direct all persons currently affiliated and/or employed by Sewerage District Nos. 1 and 3, and any and all future employees.
- c. Work in conjunction with other parish departments and agencies as they interface with sewer works.
- **d.** Develop a comprehensive parishwide sewerage management system including operations, capital improvements and personal systems.
- e. Prepare annual operating and capital budgets for presentation to the council.
- 6. Supervise and coordinate engineering studies for ongoing and future projects including, but not limited to:
 - 1. sewerage
 - drainage
 - 3. Levee systems
 - 4. streets
 - 5. subdivision regulation review through the planning department
 - 6. site plan review through the planning department
- g. Other such duties as may be required by the parish president

SECTION III. That the Director of the Department of Sewerage shall be appointed by the Parish President as stated in Article III, Section C.1.b. of the Home Rule Charter
