WHEREAS, Civil & Environmental Consulting Engineers has reviewed the bids and recommend that the Contract be awarded to the low bidder, Deep South Construction & Salvage, LLC in the amount of \$589,265.00.

Box 302, Hahnville, LA 70057, through its Parish President, Matthew Jewell, duly authorized by Ordinance No. 20-5-6, adopted by the St. Charles Parish Council on May 4, 2020, and Deep South Construction & Salvage, LLC, 9266 Hwy. 23, Belle Chasse, LA 70037, through Chad Madere, Manager, entered into a contract to furnish all labor and materials and perform all of the work required to build, construct, and complete in a thorough and workmanlike manner: Project No. WWKS 98, West Bank River Intake Modifications, in St. Charles Parish, Louisiana for the price and sum of FIVE HUNDRED, EIGHTY-NINE THOUSAND, TWO HUNDRED AND SIXTY-FIVE DOLLARS AND 00/100 (\$589,265.00).
