**ORDINANCE NO.** 09-4-13

An ordinance to amend Sec 7.2 Open-Swale Drainage Systems; Construction Specifications and Administrative Procedures, (a).(6) of the ST CHARLES PARISH CODE to allow the use of ribbed polyvinyl chloride and ribbed polyethylene culvert pipe.

WHEREAS, St Charles Parish has permitted the use of and has used polyvinyl chloride and ribbed polyethylene culvert pipe in its maintenance of the Parish drainage system; and,

WHEREAS, Sec 7.2.(a).(6) does not allow for the use of neither polyvinyl chloride culvert pipe nor ribbed polyethylene culvert pipe; and,

**WHEREAS**, it is in the best interest of St. Charles Parish to use this often times superior product in its drainage system.

## THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

## ST CHARLES PARISH CODE:

Sec 7.2.(a).(6): Culvert sizes shall match those for the lot or parcel as shown on the approved subdivision plan. Culverts may be either corrugated steel, bituminous coated corrugated steel pipe, or concrete. All corrugated steel pipe utilized within both the state's and parish's right of ways shall be bituminous coated corrugated steel pipe. (see section 21-1 for further details).

## Shall be amended to read as follows (changes in bold type):

Sec 7.2.(a).(6): Culvert sizes shall match those for the lot or parcel as shown on the approved subdivision plan. Culverts may be either corrugated steel, bituminous coated corrugated steel pipe, **ribbed polyvinyl chloride**, **ribbed polyethylene** or concrete. All corrugated steel pipe utilized within both the state's and parish's right of ways shall be bituminous coated corrugated steel pipe. (see section 21-1 for further details).
