> An ordinance of the Parish of St. Charles providing that the Code of Ordinances, Parish of St. Charles, be amended by revising Section 15-5, Motor Vehicles and Traffic, of said Code, to provide for the installation of one (1) "NO PARKING" sign on the north side of Almedia Plantation Drive in St. Rose from the corner of Johnson Street extending forty-four (44) feet.

WHEREAS, vehicles obstructing the passage of moving vehicular traffic poses a threat to the health, safety, and welfare of the general public in the event that emergency vehicles are obstructed in responding to an emergency; and,

WHEREAS, vehicles parking on this street obstruct the passage of moving vehicular traffic including school buses, garbage trucks, and other vehicles to pass;

WHEREAS, no parking signs are needed in order to eliminate the safety hazard and danger to residents.

THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS:

SECTION I. Traffic control signs have been posted by the Department of Public Works since the adoption of Ordinance No. 82-10-9.

SECTION II. In accordance with Section 15-5, Motor Vehicles and Traffic, of the St. Charles Parish Code of Ordinances, the Department of Public Works is hereby authorized to order the erection, removal and location of such traffic control signs, signals, devices and markings as provided in the chapter or any amendments thereto.

NOW, THEREFORE, WE, THE MEMBERS OF THE ST. CHARLES PARISH COUNCIL, DO HEREBY ORDAIN that one (1) "NO PARKING" sign be installed on Almedia Plantation Drive in St. Rose from the corner of Johnson Street extending forty-four (44) feet.
