OWNER: St. Charles Parish will assume insurance upon final payment. No warranties or guarantees will be assumed by St. Charles Parish until the one-year warranty/guarantee period has ended, in full accordance with Article 13.12 of Section 00700 of the Road Maintenance 2006 Contract Documents.

CONTRACTOR: Contractor shall remain responsible for security of equipment and materials, safety, and maintenance during completion of punchlist items. Contractor shall maintain all warranties and guarantees for a period of one year after the substantial completion date, in full accordance with Article 13.12 of Section 00700 of the Road Maintenance 2006 Contract Documents.





**Substantial Completion Punchlist for  
"Road Maintenance 2006"**

1. **The water valve at the corner of Birch Street and Mimosa Street needs to be raised to street level.**
2. **The asphalt on the shoulders along Clayton Street needs to be dressed up with appropriate shoulder material.**
3. **Shoulder material required on Clayton Street at the intersection with Eighth Street. The location is on the southwest corner of the intersection near the yard drain.**
4. **Chip out the water valve located at the intersection of Short Street and Post Street (Schoolhouse Road area).**
5. **Shoulder material is required in two locations on Schoolhouse Road. The first location is along the corner at the intersection of Schoolhouse Road and Short Street. The second location is on the south end of the road by the old abandoned school building between the two driveways.**
6. **All manholes must be checked to ensure that each one will open.**
7. **Clean up required on Bayou Estates Drive to remove excess asphalt from roadsides.**
