To REBATE all applicable local sales/use taxes on the purchase of eligible construction materials. machinery, and equipment purchased and used by the business permanently on that site for projects endorsed by this body. CHARLES PARISH COUNCIL do hereby request designation by the Louisiana Department of Economic Development of Census Tract 621 and Block Group 001 as an Enterprise Zone. BE IT FURTHER RESOLVED if any provision or item of this resolution or the application thereof is held invalid, such invalidity shall not affect other provisions, items or applications of this resolution which can be given effect without the invalid provisions, items or applications and to this end the provisions of this resolution are hereby : declared severable.
