A resolution requesting the Louisiana Department of
Transportation & Development to stripe US 61 for a right
turning lane, going south, at the following locations.
US 61 and Goodhope Street, Motiva's Airline Gate,
Motiva's Contractors Gate A30 and Gate 44, and to
extend the turning lane at Ormond Boulevard to include
the strip mall and LA 626.
WHEREAS, striping US 61 for a right turning lane and extending the existing turning lane
would allow vehicles that must slow down to turn right an opportunity to exit the
highway safely; and,
WHEREAS, providing right turn lanes with striping would allow the flow of traffic to move at
safe nace and help in avoiding rear end collisions; and,
WHEREAS, with the open span of roadway, the many large trucks, and with the enormou
amount of vehicular traffic traveling at high rates of speed on US 61, vehicle
turning right can cause a very dangerous and difficult situation.

PARISH COUNCIL do hereby request the Louisiana Department of Transportation
Development to stripe US 61 for a right turning lane, going south, at the following location
