
NOTICE OF CONTRACT

PLEASE TAKE NOTICE that by virtue of a written contract dated October 9, 2014, St. Charles Parish, 15045 River Road, P. O. Box 302, Hahnville, LA 70057, through its Parish President, V. J. St. Pierre, Jr., duly authorized by Ordinance No. 14-10-9 adopted by the St. Charles Parish Council on October 6, 2014 and BLD Services, LLC 2424 Tyler Street Kenner, LA 70062 through Thomas Behan, Project Manager, entered into a contract to furnish labor, materials and equipment for the construction and completion of the Fairfield and Oakland Conveyance and Pump Station Upgrades project in St. Charles Parish, Louisiana for the price and sum of SEVEN HUNDRED FORTY NINE THOUSAND AND FIFTY (\$749,050.00) DOLLARS, the work under the Contract to be completed within one hundred twenty (120) calendar days from the date of the Notice to Proceed. Said basic work to include select demolition and construction of area pump stations. The work includes removing existing wooden bar screens, timber piles, wooden sheeting, and metal decking and associated supports. The work also includes installing new steel bar screens, pipe piles, steel decking and supports, wooden sheeting, concrete footings, and soil stabilization methods. All necessary appurtenances for a complete and proper installation in accordance with the plans and specifications as shown on the Drawings, Specifications and Contract Documents for the Fairfield and Oakland Conveyance and Pump Station Upgrades Project No. P090301 as prepared by Principal Engineering, LLC in July 2014. The contract price is firm and subject only to modifications by written change order agreed to by both parties. Contractor shall submit Application for Payment in accordance with the General Conditions. The complete Contract Documents and Specifications may be reviewed at the Records Office of the St. Charles Parish Council, Parish Courthouse, 15045 River Road, Hahnville, LA.

The property upon which the above described improvements are to be constructed is generally described as Fairfield and Oakland Conveyance and Pump Station Upgrades Project No. P090301 in St. Rose in St. Charles Parish, located as per the detailed plans and specifications prepared by Principal Engineering, LLC.
